SUMMARY:

- Pursuant to Chapter VA 6.01 (16) Wisconsin Administrative Code, the Wisconsin Department of Veterans Affairs (WDVA) must adjust care and maintenance charges, or daily rates, to reflect estimated costs.
- Daily rates will be calculated every January and may be revised in July of the same year to reflect any changes in costs.
- The WDVA will provide written notice thirty (30) days prior to the change in rates to members/legal representatives.
- Veterans with a permanent service-connected disability rating fitting one of the criteria below are entitled to receive nursing home care paid by the VA – see 38 USCS 1745(a)(3) (per VA Benefits Manual, sect 10.7):
 - is in need of nursing home care for a service connected disability; or
 - is rated at least 70 percent disabled due to a service-connected disability or disabilities; or
 - has a rating of total disability based on individual unemployability (TDIU).
- Each Veterans Home receives a nursing care per diem, set by the United States Department of Veterans Affairs (USDVA), to help cover the cost of care for each qualifying veteran member. The effective date of the current USDVA per diem is October 1, 2015.
- Veterans eligible for the USDVA per diem must meet requirements per 38 CFR 51.50 unless they were enrolled in the VA healthcare system prior to 2003.
- Daily rates will continue to be charged to maintain residency when a member is out of the facility. After 15 nights, a member may be discharged unless they request to maintain their residency at the full care rate.
- Member absence from the Wisconsin Veterans Home past midnight will be counted as a bed hold day.

Skilled Nursing Facility Bed Hold considerations:

Out of facility, hospital stay:

Qualifying Veteran: The USDVA per diem will continue for the first 10 consecutive nights of each hospital stay. The full care rate is charged beginning with day 11.

Non-Qualifying: Full care rate is charged for the entire absence.

Out of facility, other than hospital stay:

Qualifying Veteran: The USDVA per diem will continue for the first 12 nights of absence per calendar year. The full care rate is charged beginning with day 13.

Non-Qualifying: Full care rate is charged for entire absence.

Assisted Living Bed Hold considerations(at Union Grove facility only):

Qualifying Veteran: VA hospital stays **not exceeding 96 hours** are billed at the veteran rate.

Non-VA hospital stays **exceeding 96 hours** are billed at the full care rate retroactive to day 1.

VA hospital stays will be billed at the full care rate effective day 1.

All other absences **not exceeding 96 hours** are billed at the veteran rate.

All other absences **exceeding 96 hours** are billed at the full care rate retroactive to day 1

Non-Qualifying: Full care rate is charged for entire absence.
