1. Call to order and roll call

2. Briefing by Chippewa Falls Commandant

The Chair introduced Mark Wilson, the Commandant of the Wisconsin Veterans Home at Chippewa Falls. Mr. Wilson shared current information regarding the Wisconsin Veterans Home at Chippewa Falls.

- Opened in 2013
- 72 bed facility with 4 ea. 18 unit wings
- Residents must require 24 hour skilled nursing care
- Dimensions Healthcare contract staff
- 290 applications on file
- 90 applicants actively waiting for admission

3. Certification of notice of meeting

Proper notification of the meeting occurred.

4. Board action on minutes from Board's November 20, 2015 meeting at WDVA in Union Grove

It was moved, seconded, and carried unanimously on a voice vote to approve the minutes for the meeting held on November 20, 2015 in Union Grove with the changes requested by Board Member Dan Bohlin, Board Secretary.

5. Chairs Comments

Chairman Gaedke thanked former Chair, John Townsend, for his contributions as the Chair and as a member of the Board. Chairman Gaedke expressed that he accepted a position on the board, so that he can work to help Wisconsin veterans. He expressed that helping people makes him feel good, and he hopes the other board members feel the same.

6. VORP Briefing

WDVA staff member Nicole Lillis provided information on the Veterans Outreach and Recovery Program (VORP) (details in Attachment 1).

7. VHRP Briefing

WDVA staff member Kent Falstad provided information on the Veterans Housing and Recovery Program (VHRP) (details in Attachment 2).

8. STAR Briefing

Overview and status of the new State Transforming Agency Resources (STAR) provided by WDVA Deputy Secretary Kathy Marschman (details in Attachment 3).

9. Secretary's Comments

WDVA Highlights provided by WDVA Deputy Secretary Kathy Marschman (details in Attachment 4).

Legislative updates provided by WDVA Assistant Deputy Secretary Dan Buttery (details in Attachment 5).

Information was shared on how board members can get notified of veteran related legislation. Board members were encouraged to contact Roger Fetterly, MOAA representative for the Council on Veterans Programs, to obtain additional information on getting "plugged in" to upcoming veterans legislation.

In closing, Deputy Secretary Marschman added that the legislative language that was proposed to help improve the financial status of the department did not make it through the legislative process. The department has been informed that they should not expect to receive any GPR funding, through the next budget cycle, so they have to solely rely on the Veterans Trust Fund, which is a finite amount.

10. Public Comment

Former state Senator Dave spoke about the possibly of reintroducing legislation that would send a percentage of the taxes from mineral sales in the state of Wisconsin to the Veterans Trust Fund. He also spoke about events related to the 50 Anniversary of the War Vietnam.

David Schmidt shared that sale of any land that is used for mining frac sand is not subject to sales or use taxes. He shared the this was brought up by a member of the COVP, and they plan to put together a resolution suggesting that we look into this as a potential source of funding for the Veterans Trust Fund.

11. Adjournment


A motion was made by Mr. Kutschma to adjourn the meeting. The motion was seconded and carried on a voice vote.





**Veteran Housing and Recovery Program (VHRP)**

**What qualifies a veteran for the program?**

- Veteran must have served on Active Duty for at least 1 day.
- Cannot be on the Lifetime Sex Offender List nor have committed a violent crime.
- If veteran has drug and alcohol complications they must first complete a treatment program.
- Eligibility for the program is determined by case managers and the federal VA.

### Where are the Housing Programs Located? What is a Veteran Housing Program Like?

Veteran Housing Programs are located at:

- Chippewa Falls in Chippewa County
- King in Waupaca County
- Union Grove in Racine County

Each housing program offers clean, safe, and secure accommodations. There is a full meal plan available. The program's staff members are highly trained professionals who are dedicated to serving veterans and provide the veteran with ongoing support.

All veterans have work responsibilities while residing in one of the housing program locations. Veterans will often work together to maintain the center. This discipline and hard work serves to restore each veteran's pride, confidence, and self-esteem.

A transitional program participant may also earn money while in the program that will be placed in their savings account. These earnings may be used to obtain other housing options after the veteran completes the program.

Veterans may be assessed a program fee of up to 30% of their gross income.

## Who is Eligible to Participate in the VHRP?

All in state and out-of-state veterans who have served in the U.S. Armed Forces are eligible. The Wisconsin Department of Veterans Affairs will confirm military service and eligibility.

## What About the Veteran's Family?

Spouses and dependent children are not eligible at this time, unless the spouse is also a veteran. However, the VHRP staff will assist the veteran's family with obtaining adequate housing while the veteran is in a transitional program.

## How Long is the Transitional Program?

Generally, most veterans can complete their individual program in about 6-10 months. Others may complete their program in less time, but the maximum duration of the transitional program is 2 years.

The VHRP offers stable, secure, and safe housing to both male and female homeless veterans while they receive the training and other services necessary to become self-supporting.

The VHRP also can assist veterans who are at risk of becoming homeless and need job training and other services.

The VHRP affords veterans access to a wide array of services such as:

- Temporary and Permanent Housing
- Job Training
- Education
- Counseling
- Health care, including treatment of PTSD (post-traumatic stress disorder)
- Treatment for alcohol or drug abuse issues
- Benefits and entitlements

A VHRP staff member along with the contractor and VA Case workers will interview each veteran to make an assessment and determine immediate and long-term needs. Then the veteran and VHRP staff member can agree on a specific program that addresses those needs.

Applicants who need immediate medical attention or treatment for drug/alcohol problems will receive those services as quickly as possible.

Applicants with drug or alcohol problems must first successfully complete a treatment program before they continue in the VHRP program.

Based on their housing needs, veterans may:

- Live and work at the Housing Program while they receive services offered through the VHRP.

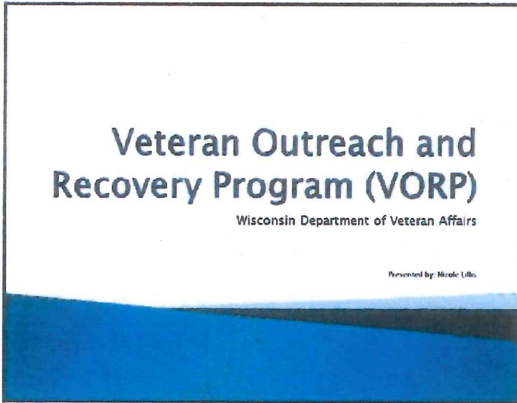
## Long Term Affordable Housing

Both Chippewa Falls and Union Grove have suites available to those veterans needing long-term affordable housing in a secure and safe environment.

This housing is open to any veteran who has completed the transitional program or who is in need of temporary or permanent housing. All veterans entering these programs must complete an application process and must have sufficient income in order to pay the monthly program fee.

*The goal of the Veterans Housing and Recovery Program is to assist military veterans who are homeless or at risk of becoming homeless in obtaining temporary or permanent housing, in addition to providing other services that will enable them to reintegrate back to the community.*

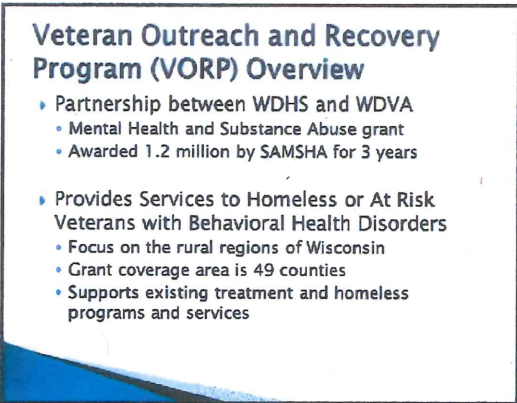

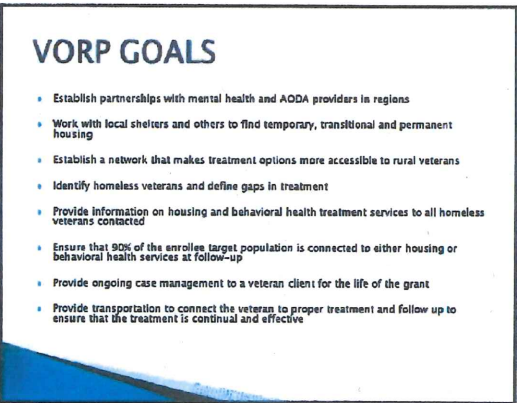

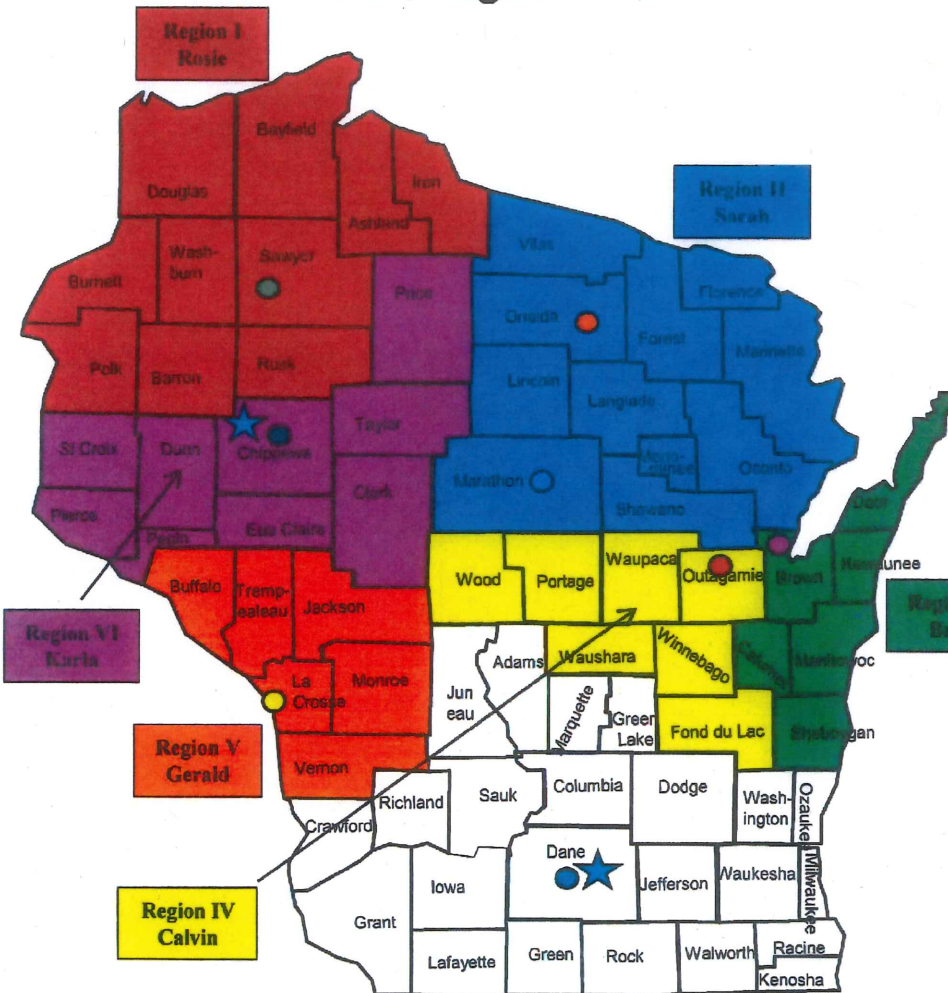

 Recovery from mental health and substance use concerns is a process. The Veterans Outreach and Recovery Program (VORP) is designed to help veterans and former service members start this journey.

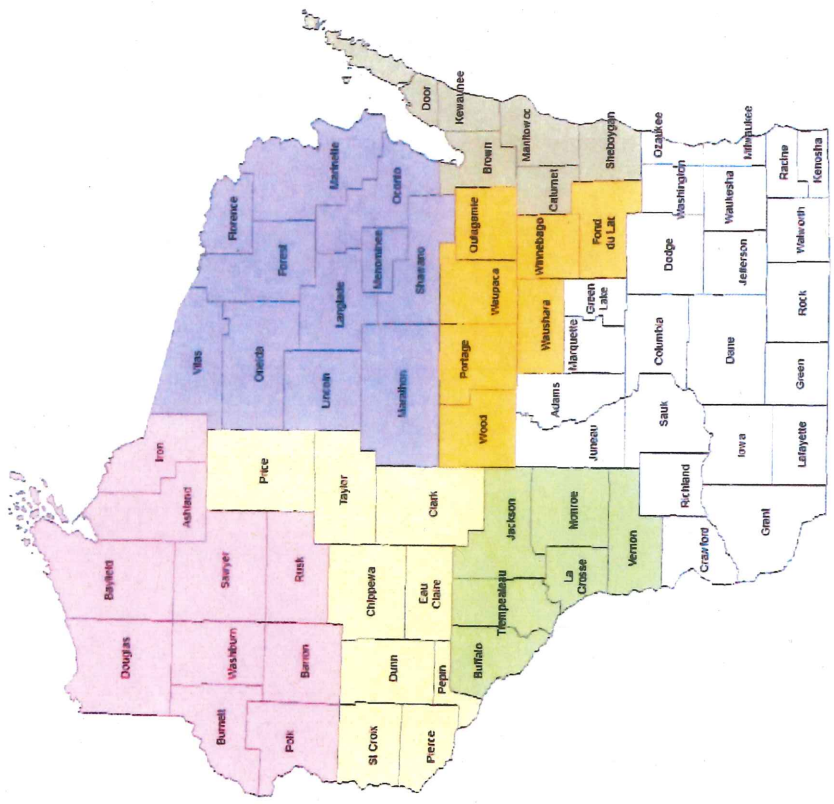
**Who is Eligible?**

Assistance is available to homeless veterans and former service members regardless of discharge status who have a mental health and/or substance use concern. Veterans or former service members with these conditions at-risk for homelessness may also qualify. The enrollment process includes a screening for needs.

**Support is Available.**

Program staff work with mental health and substance use services professionals to provide behavioral health support services needed to address mental health or substance use and to place veterans on a path to obtain stable housing.

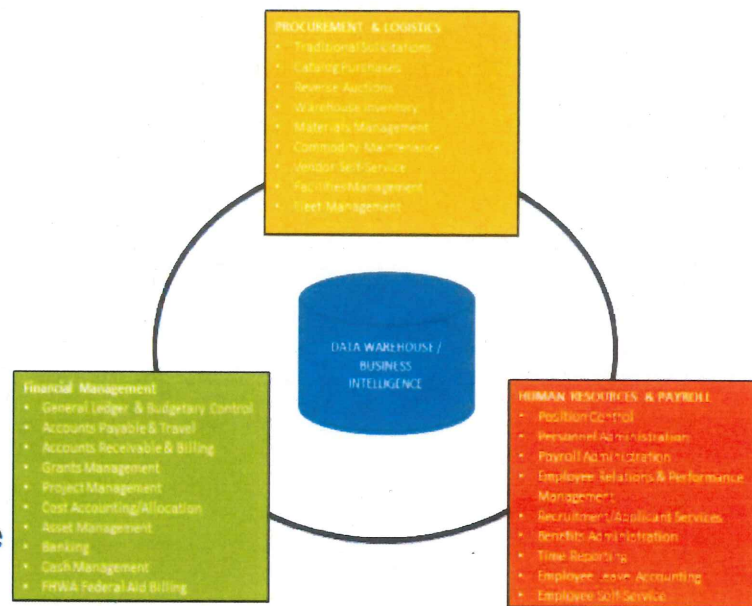
