Minutes from September 19, 2024 were reviewed:

• MOTION: Kim Queen made a motion to approve the minutes, second by Bill Hustad; minutes were unanimously approved.

Executive Staff Assistant Dawn LaFond provided an Administrative Update.

- Holiday ornaments that were made by Wisconsin school children and left over from the State Capitol

Presentation on Department of Defense's efforts with state policymakers to support military families

- Shane Preston, who is the liaison between the Department of Defense and the Great Lakes Region, presented information on various DOD initiatives with State Legislatures to improve life for military servicemembers:
 - Access to quality child care
 - Child abuse neglect and reporting
 - o Remote driver's license and vehicle registration renewal
 - Concurrent juvenile jurisdiction
 - Military spouse employment and economic opportunities
 - Discrimination protection for military families
 - Occupational licensure and interstate compacts
 - State response to military interpersonal violence
 - Defining Armed Forces in State Policy
 - Open enrollment flexibility
 - State support of military families with special education needs
 - Military community representation on state boards and councils

Assistant Deputy Secretary Joseph Hoey provided updates to the Board covering the following topics:

- Joint Finance Committee ("JFC") updates
 - Appointments to JFC includes three members who are veterans:
 - Rep. Tony Kurtz (R-Wonewoc)
 - Rep. Karen Hurd (R-Withee)
 - Sen. Eric Wimberger (R-Green Bay)
- Legislature's Veterans Committees updates
 - New Assembly Chair Rep. Penterman (R Hustisford)
 - Additional Assembly members and Senate Membership TBD
- WDVA Updates
 - Budget
 - WDVA's 2025-2027 biennial budget request was submitted to the Department of Administration on September 16, 2024
 - Request for GPR dollars was submitted for the Homes, which was the first time this has ever been requested
 - Request for Legislature to make the expanded positions for Veterans Outreach Recovery Program ("VORP") permanent (from 11 positions to 16 positions)

- Request for additional funding for Veterans Housing Recovery Program
 ("VHRP"), which is funded primarily with federal government (VA) Per Diem
 Payments.
- Museum purchase
