WISCONSIN BENEFITS/POPULAR BENEFITS

VETERANS PROPERTY TAX CREDIT

Refundable credit on primary residences for veterans with a 100% Service-Connected Disability.



VETERAN IDENTIFIER

Add "Veteran" to your Wisconsin Driver's License or state ID.

OUTDOOR RECREATION

Discounted and free access to hunting and fishing licenses, as well as park admissions provided by the Department of Natural Resources.

FIND YOUR COUNTY OR TRIBAL **VETERAN SERVICE OFFICER**

EDUCATION & EMPLOYMENT BENEFITS

WISCONSIN GI BILL

Waives tuition for up to 8 semesters/128 credits at any UW System or Wisconsin Technical Colleges for veterans, spouses, and dependents.

VETERANS GRANT FOR NONPROFIT PRIVATE SCHOOLS

Veterans may receive up to a \$2,000 grant for veterans at nonprofit private colleges, with institutional matching.

RETRAINING GRANT

Up to \$3,000 for retraining unemployed veterans.

LICENSURE FEE WAIVER

Fee waivers for initial professional licenses and permits.

HONORING A LIFETIME OF SERVICE



WISCONSIN VETERANS HOMES

Veterans, spouses, and parents of veterans who were killed while on active duty may receive 24-hour skilled nursing care at one of Wisconsin's Veterans Homes in Chippewa Falls, King, or Union Grove.



WISCONSIN VETERANS CEMETERIES

Veterans, spouses, surviving spouses, and eligible family members may be buried at Wisconsin Veterans Cemeteries located near Union Grove, Spooner, and King, a lasting tribute to those who served in the armed forces.

MILITARY FUNERAL HONORS

Provides and coordinates funeral honors for veterans and former National Guard and reservists, including the presence of military members, folding and presentation of the flag, firing details, and the sounding of Taps.

WISCONSIN VETERANS MUSEUM

Consists of exhibits, living histories, informational programs, speakers, and much more, educating the public with the unique stories and history of Wisconsin's veterans.

SUPPORT FOR UNDERSERVED VETERANS

VETERAN OUTREACH AND RECOVERY PROGRAM (VORP)

Connects veterans to community services and provides case management and support, focusing on treatment and recovery. VORP has regional coordinators covering the entire state of Wisconsin.

VETERAN HOUSING AND RECOVERY PROGRAM (VHRP)

Provides temporary housing, training, education, counseling, and supportive services to military veterans who are homeless or at risk of becoming homeless. VHRP is located in Union Grove, south of the Milwaukee area.

SUBSISTENCE AID GRANTS

Applicants who demonstrate financial need and have exhausted other forms of aid may qualify when there is a loss of income due to illness, injury, or economic injury.

HEALTH CARE AID GRANTS

Applicants who demonstrate financial need and have exhausted other forms of aid may qualify for help with costs for dental care, vision care, and hearing care by a healthcare provider of the applicant's choice.
